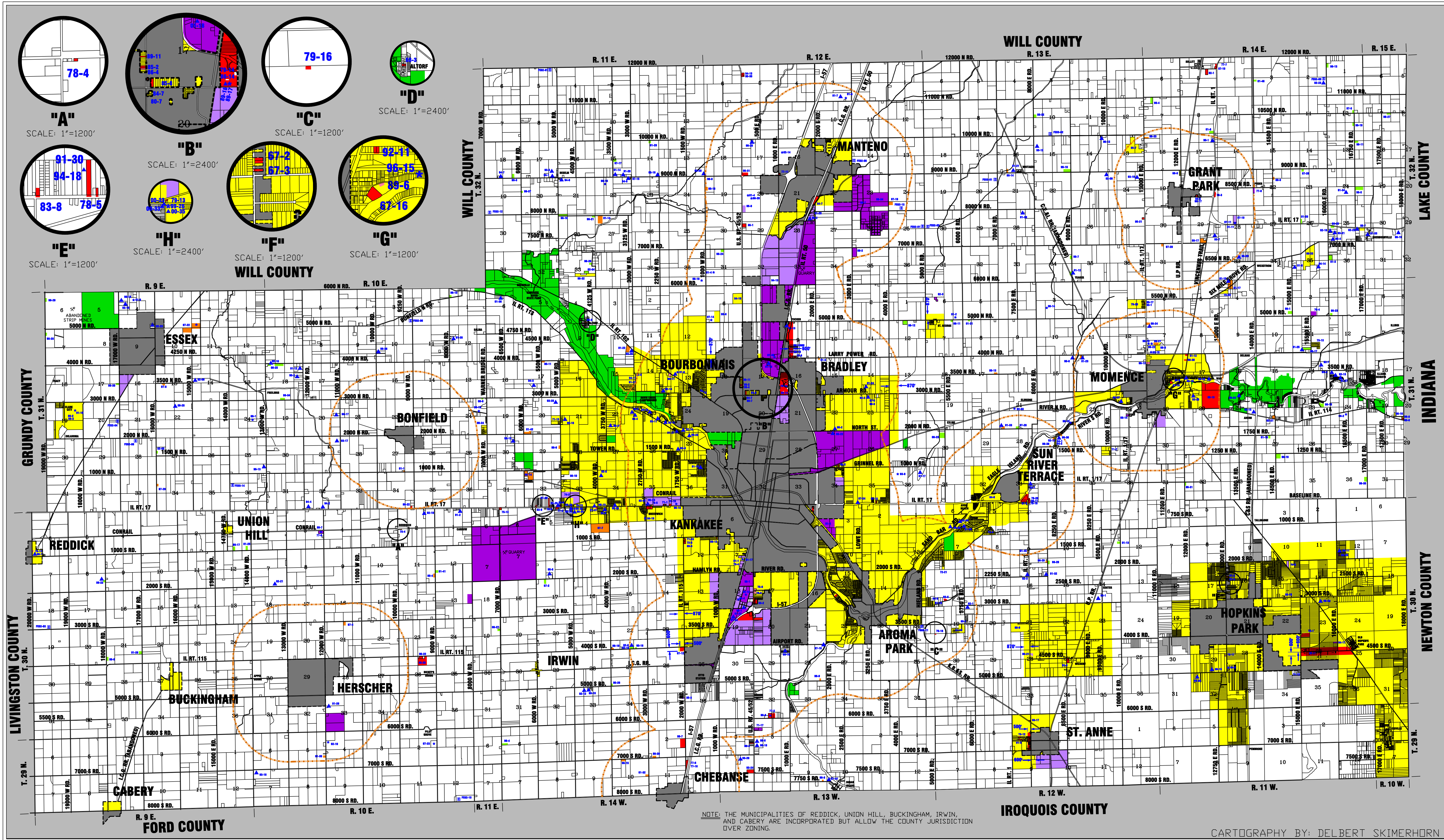

NOTES

DISTRICT BOUNDARY LINES ARE EITHER: THE CENTER LINES OF RAILROADS, HIGHWAYS, STREETS, ALLEYS, EASEMENTS, OR OTHER LINES OF DIVISION. THE BOUNDARIES ARE NOT LOCATED AS SET FORTH ABOVE, THE SOUTH OF SUCH LINES SHALL BE IN ACCORDANCE WITH THE LINES SHOWN ON THE MAP MEASURED AT RIGHT ANGLES FROM THE CENTER LINES OF THE STREET OR HIGHWAY, AND THE LENGTH OF PORTION SHALL BE IN ACCORDANCE WITH DIMENSIONS SHOWN ON THE MAP FROM SECTION, QUARTER SECTION, OR DIVISION LINES, OR CENTER LINES OF STREETS, HIGHWAYS, OR RAILROAD RIGHTS-OF-WAY UNLESS OTHERWISE INDICATED.

WHEREVER A DISTRICT IS INDICATED AS A STRIP ADJACENT TO AND PARALLELING A STREET OR HIGHWAY, AND THE BOUNDARIES ARE NOT LOCATED AS SET FORTH ABOVE, THE SOUTH OF SUCH LINES SHALL BE IN ACCORDANCE WITH THE LINES SHOWN ON THE MAP MEASURED AT RIGHT ANGLES FROM THE CENTER LINES OF THE STREET OR HIGHWAY, AND THE LENGTH OF PORTION SHALL BE IN ACCORDANCE WITH DIMENSIONS SHOWN ON THE MAP FROM SECTION, QUARTER SECTION, OR DIVISION LINES, OR CENTER LINES OF STREETS, HIGHWAYS, OR RAILROAD RIGHTS-OF-WAY UNLESS OTHERWISE INDICATED.
